**FOR THREE-YEAR-OLDS** By subscription of \$500 each to accompany the nomination (EARLY BIRD) on or before Wednesday, December 27, 2017. Early Bird nominees to the Santa Anita Derby are automatically eligible to, the Sham Stakes (Grade III), the Robert B. Lewis Stakes (Grade III), and the San Felipe Stakes (Grade II) with nomination and starting fees waived to those stakes. Regular nominations close Saturday, March 24, 2017 by payment of \$2,500 each. Supplementary nominations are due at time of entry, by payment of \$20,000. All horses shall pay \$7,500 to enter and \$7,500 to start, with \$1,000,000 guaranteed. The winner to receive \$600,000 PLUS 100 KENTUCKY DERBY POINTS, \$200,000 (40 Points) to second \$120,000 (20 Points) to third, \$50,000 (10 Points) to fourth, \$20,000 to fifth and \$10,000 to sixth. 124 lbs. Starters to be named through the entry box by the closing time of entries. A trophy will be presented to the winning owner.
