Goodwood Stakes Breeders' Cup "Win and You're In" Challenge Race \$300,000 Guaranteed

(Grade I)

FOR THREE-YEAR-OLDS AND UPWARD By subscription of \$100 each if made on or before Sunday, September 14, 2025, or by Supplementary nomination of \$6,000 due at time of entry. \$2,250 to enter and an additional \$2,250 to start with \$300,000 guaranteed of which \$180,000 to the winner, \$60,000 to second, \$36,000 to third, \$18,000 to fourth and \$6,000 to fifth. Three-Year-Olds 122 lbs. Older 126 lbs. Non-Winners of a Grade I Stake at One Mile or Over since March 27, 2025, allowed 2 lbs. Non-Winners of a Graded Stake at One Mile or Over since September 27, 2024 allowed 4 lbs. The Goodwood Stakes has been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The nominated winner of the Goodwood Stakes will be entitled to automatic entry into the 2025 running of the Breeders' Cup Classic. The nominated winner will also be entitled to have pre-entry and entry fees waived for the 2025 Breeders' Cup Classic or will receive a credit equal to the Breeders' Cup Classic pre-entry and entry fee amount towards any other 2025 Breeders' Cup Championship race. All horses will be entitled to receive a travel stipend if traveling from a base located outside the state of California. To be eligible for the 2025 Breeders' Cup World Championships to be held at Del Mar on October 31 and November 1, 2025, all horses must be pre-entered by noon (local standard time at the designated place of pre-entry) on Monday, October 20, 2025. Winner must be nominated by pre-entry deadline to receive Challenge rewards. All Breeders' Cup Challenge Races and Breeders' Cup World Championship races are to be run Lasix free and in accordance with Breeders' Cup Limited rules as they may be published and/or amended from time to time, which rules are hereby expressly incorporated by this reference. All runners nominated to Challenge races and all Challenge winners are subject to out-of-competition testing by HIWU on behalf of HISA (or their respective designees). Breeders' Cup Limited reserves the right in its sole discretion to postpone, disc
