FOR FILLIES THREE YEARS OLD By subscription of \$100 each if made on or before Friday, December 12, 2025, or by Supplementary nomination of \$6,000 due at time of entry. \$2,250 to enter and an additional \$2,250 to start with \$300,000 guaranteed, of which \$180,000 to the winner, \$60,000 to second, \$36,000 to third, \$18,000 to fourth and \$6,000 to fifth. 124 lbs. Non-Winners of a Grade I Stake since June 26, 2025 allowed 2 lbs. Non-Winners of a Graded Stakes since December 26, 2024 allowed 4 lbs. Highweights preferred followed by Graded or Group winners, Grade or Group placed horses, followed by Stake winners, Stake placed horses and horses with the highest Non-Claiming or Starter earnings at the time of entry. Graded or Group winners have first preference regardless of weight. Starters to be named through the entry box by the closing time of entries. A trophy will be presented to the winning owner.
