The added monies and all fees to be divided 60% to the winner, 20% to second, 12% to third, 6% to fourth and 2% to fifth. Three-Year-Olds 122 lbs. Older 126 lbs. Non-Winners of a Sweepstakes at One Mile or Over allowed 2 lbs. Non-Winners of Two races other than Maiden, Claiming or Starter at One Mile or Over allowed 4 lbs. Starters to be named through the entry box by the usual time of closing.
