





Oak Leaf Stakes presented by Oak Tree Racing Association Breeders' Cup "Win and You're In" Challenge Race \$200,000 Guaranteed

(Grade II)

FOR FILLIES, TWO YEARS OLD By subscription of \$100 each if made on or before Sunday, September 21, 2025 or by Supplementary nomination of \$4,000 due at time of entry. \$1,500 to enter and an additional \$1,500 to start with \$200,000 guaranteed. The winner to receive \$120,000, (PLUS 10 KY Oaks points) \$40,000 to second, (PLUS 5 KY Oaks points) \$24,000 to third, (PLUS 3 KY Oaks points) \$12,000 to fourth, (PLUS 2 KY Oaks points) and \$4,000 to fifth, (PLUS 1 KY Oaks point). Weight 122 lbs. The Oak Leaf has been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The nominated winner of the Oak Leaf will be entitled to automatic entry into the 2025 running of the Breeders' Cup Juvenile Fillies. The nominated winner will also be entitled to have pre-entry and entry fees waived for the 2025 Breeders' Cup Juvenile Fillies or will receive a credit equal to the Breeders' Cup Juvenile Fillies pre-entry and entry fee amount towards any other 2025 Breeders' Cup Championship race. All horses will be entitled to receive a travel stipend if traveling from a base located outside the state of California. To be eligible for the 2025 Breeders' Cup World Championships held at Del Mar on October 31 and November 1, 2025, all horses must be pre-entered by noon (local standard time at the designated place of pre-entry) on Monday, October 20, 2025. Winner must be nominated by pre-entry deadline to receive Challenge rewards. All Breeders' Cup Challenge Races and Breeders' Cup World Championship races are to be run Lasix free and in accordance with Breeders' Cup Limited rules as they may be published and/or amended from time to time, which rules are hereby expressly incorporated by this reference. All runners nominated to Challenge races and all Challenge winners are subject to out-of-competition testing by HIWU are hereby expressly incorporated by this reference. All runners nominated to Challenge races and all Challenge winners are subject to out-of-competition testing by HIWU on behalf of HISA (or their respective designees). Breeders' Cup Limited reserves the right in its sole discretion to postpone, discontinue, amend, or change the conditions of all or any part of the Breeders' Cup Challenge "Win & You're In" race program. Starters to be named through the entry box by closing time of entries. A trophy will be presented to the winning owner.
