**FOR THREE-YEAR-OLDS** By subscription of \$100 each to accompany the nomination or by supplementary nomination of \$6,000 due at time of entry. \$2,250 to the enter (Horses that start in the race will have entry fee waived) and an additional \$2,250 to start with \$300,000 guaranteed, of which \$180,000 to the winner, \$60,000 to second, \$36,000 to third, \$18,000 to fourth and \$6,000 to fifth. 124 lbs. Non-winners of a Grade I Stake since June 26, 2020 allowed 2 lbs. Non-winners of a Graded Stakes since December 26, 2019 allowed 4 lbs. Highweights preferred followed by Graded or Group winners, Grade or Group placed horses, followed by stake placed horses and horses with the highest non-claiming earnings at time of entry. Graded or Group winners have first preference regardless of weight. Starters to be named through the entry box by the closing time of entries. A trophy will be presented to the winning owner.
